QUALIFICATIONS:-

For Lecturer

- i. Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii. NET/SET shall remain the minimum eligibility condition for recruitment and appointment of Lecturers in Universities/Colleges/Institutions.

Provided, however, that candidates, who are or have been awarded Ph.D. degree in compliance of the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/ Institutions.

FOR REMOTE SENSING & GIS

- i. Master's Degree in Remote Sensing & GIS with NET/SET in the relevant subject with not less than 55% of marks
Or
Master's Degree in Geology/Geography/Botany/Agriculture/Environmental Sciences with PG Diploma in Remote Sensing & GIS and NET/SET in the Relevant Subject with not less than 55% marks. In case of candidates having Master's Degree in Geology/Geography/Botany/Agriculture/ Environmental Sciences, preference shall be given to candidates having substantive research and publications in Remote Sensing & GIS at the PhD. Level.
- ii. Provided, however, that candidates, who are or have been awarded Ph.D. degree in compliance of the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/ Institutions.

1. First Class Masters Degree in Business Management / Administration /MBA-IB in a relevant management related discipline or first class in two year full time PGDM declared equivalent by AIU / accredited by the AICTE / UGC;

2. First Class graduate and professionally qualified Chartered Accountant / Cost and Works Accountant / Company Secretary of the concerned statutory bodies.

- First Class graduate and professionally qualified Chartered Accountant / Cost and Works Accountant / Company Secretary of the concerned statutory bodies.

Desirable:

2. Papers presented at Conferences and / or published in refereed journals.

3. NET/SET/Ph.D. in Management/allied discipline.

FOR TEACHING FACULTY IN MBA (HOSPITALITY & TOURISM) COURSE:

1. First Class Master's Degree in MBA (Hospitality & Tourism) /MTM/MTA/MBA or in an allied subject. Administration or first class in two year full time PGDHM/Administration or equivalent by AIU / accredited by the AICTE / UGC;

OR

First Class graduate and professionally qualified Chartered Accountant / Cost and Works Accountant / Company Secretary of the concerned statutory bodies.

Desirable:

1. Teaching, research, industrial and / or professional experience in a reputed organization;
2. Papers presented at Conferences and / or published in refereed journals.
3. NET/SET/Ph.D. in Management/allied discipline.

FOR Institute of Music & Fine Arts

Masters Degree in the concerned subject with at least 55% of marks. preference will be given to the candidates having passed NET/SET/Ph.D

For B.Ed. in Bhaderwah Campus

a. Foundation Courses:

1. A Master's Degree in Science / Humanities / Arts with 50% marks (or an equivalent grade in a point scale wherever grading system is followed);
2. M. Ed. With at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed); and
3. Any other stipulation prescribed by the UGC / any such affiliating body / State Government, from time to time for the positions of Principal and lecturers, shall be mandatory;

OR

1. M. A. in Education with 55% marks (or an equivalent grade in a point scale wherever grading system is followed);
2. B. Ed. with at least 55% (marks or an equivalent grade in a point scale wherever grading system is followed); and
3. Any other stipulation prescribed by the UGC / any such affiliating body /State Government, from time to time for the positions of Principal and lecturers, shall be mandatory.

b. Methodology Courses

1. A Master's Degree in a subject with 50% marks (or an equivalent grade in a point scale wherever grading system is followed);
2. M.Ed. Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed); and
3. Any other stipulation prescribed by the UGC / any such affiliating body /State Government, from time to time for the position of Principal and lecturers, shall be mandatory.

Provided that at least one lecturer should have specializations in ICT and another in the special education.

Desirable Qualification:

Qualification for core subjects.

1. M.Ed/M.A (Education) and B.Ed degree with 55% marks.
2. Desirable NET/SLET/Ph.D/M.Phil, candidates with experience/ publications in reputed national journals with impact factor.

Qualification for teaching subjects (Pedagogy subjects)

1. A master's degree in the concerned/related discipline/subject with a minimum 55% marks.
2. Teaching subjects Hindi/English/Urdu/EVS/Computer Science/ Social Science/ Commerce and Disaster Management.

For Yoga

- i. Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii. NET/SET/SLET shall remain the minimum eligibility condition for recruitment and appointment of Lecturers in Universities/Colleges/Institutions.

Provided, however, that candidates, who are or have been awarded Ph.D. degree in compliance of the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SET/SLET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/ Institutions.

Further, the award of degrees to candidates registered for the M.Phil/Ph.D. programme prior to July 11, 2009, shall be governed by the provision of the then existing ordinances/By Laws/Regulations of the Institution awarding the degrees and the Ph.D. Candidates shall be exempted from the requirement of the minimum eligibility conditions of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in University/Colleges/Institutions subject to submission of MSP certificate issued by the competent authorities of the concerned University.

NOTE:

1. However, candidates seeking exemption from NET/SLET/SET are required to produce a bona-fide certificate from the concerned University(s) to the effect that the said candidate has been awarded PhD. Degree in conformity with the UGC Regulations i.e. all the conditions laid down in University Grants Commission (minimum standards and procedure for Award of PhD. Degree) Regulations, 2009 are fulfilled by them at the time of submitting their PhD, thesis).
2. In case the eligible candidates possessing NET/SET/Ph.D. are not available, the candidates having Master's degree with 55% may also be considered as Teaching Assistants (60% for Management discipline). Their salary shall be as per University norms.

FOR GUEST FACULTY IN DEPARTMENT LAW/ GUEST FACULTY IN TAXATION AND INSURANCE & GUEST FACULTY IN PRACTICAL PAPER AND COURT VISITS IN THE LAW SCHOOL

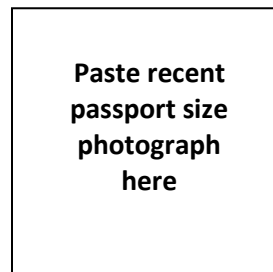
