Eligibility and Selection Procedure:

Admission to BVA & B.Mus shall be open to those candidates who have passed Higher Secondary Part-II examination under 10+2 pattern of the J&K Board of School Education or an examination recognized as equivalent there to with not less than 45% Marks for BVA and B.Mus Course (40% respectively in case of SC/ST and other category under reservation Rules). Private candidates who appeared in 10+2 whose result is still awaited can apply for admission provisionally.


