Accordingly, all the Departments are requested to submit reappropriation proposals, if any, pertaining to the requirement of funds under any object head(s) from those object heads where there is no likelihood of any further expenditure upto 31/03/2024.

The re-appropriation proposal may please be submitted only after being fairly satisfied that no additional funds shall be required upto 31/03/2024 under the object head out of which savings are proposed to be re-appropriated. Any wrongly submitted proposal which might disturb the overall budgetary allocations of the University shall solely be the responsibility of officer submitting the proposal.

The proposals may kindly be submitted strictly between 19th of February, 2024 to 29th of February, 2024 only, along with the re-appropriation forms (copy enclosed), after which no proposal(s) shall be entertained.
