Minutes of the Project Clearance Committee meeting held in the office chamber of worthy Dean Academic Affairs , University of Jammu on 18.12.2023 at 01.30 pm

At the onset of the meeting the Dean Academic Affairs extended welcome to all the members and urged them to deliberate on the various proposed projects.


Item No 1(a) To consider the Proposal regarding Construction of 250'-0" long road/path of width 20'-0"/ ie, extension of parking area from the under construction parking lot (situated at lower residential area of New University Campus) towards existing Nalah out of the savings accrued from the difference of cost between tender value and the allotted value (i.e 12.42 lakhs)

1(b) Construction of Extension of Parking Lot and Path (16'-0" wide) for an additional length of Space available i.e; 350'-0" approx by way of providing and laying of 60mm thick cement concrete Interlocking Paver Tiles including a culvert over existing Nallah for connecting the proposed Extended position of Parking Lot from Lower Residential Area upto Main Guest House chowk as per proposed plans site amounting to Rs. 138.99 lakhs.

- Resolution After threadbare discussions the committee observed that solely constructing a path or extending the parking lot to the existing nullah would not suffice. To address this, the committe recommended combining both item 1A and 1B, i.e extension of parking lot upto existing nullah, culvert over the nullah and construction of 16' wide and 350' long path by way of 60mm thick cement concrete interlocking paver tiles to connect the parking lot with the main road of the campus near university Guest house as per proposed site plan for the successful completion of the project in alignment with green campus initiatives.
 - Xen (UWD) informed that the proposed project stands checked for 151.67 lac. Xen (UWD) was also tasked with providing estimates for electric works and new Entry/Exit gates for the parking lot.
 - The committe was informed that the University has requested a one-time financial assistance of 5 crores from the Hr.Edu Deptt to meet infrastructure needs for the upcoming NAAC team's visit to the University of Jammu.

Given the project's significance for the green campus initiatives and the impending NAAC visit, the committee approved the said project in principle and recommended its time bound execution. It was further resolved that the Funding for the whole project including new entry gate(s) and electric works will be sourced from the proposed one-time grant for NAAC visit. However in case, if the funds are not sanctioned/released by the Hr.Edu Deptt, the University will proceed with the project using infrastructure funds subject to concurrence from Infrastructure fund committee.





Resolution: Keeping in view recommendation of the Building Committee and importance of the project the committee approved the project in principle and recommended to propose this project in the capital expenditure (Capex) Budget for the fiscal 2024-25 for funding (amounting to Rs 665.00 lac)

Item No 3: To consider the Proposal/Detailed Estimate for construction of concrete Footpath from Rear Gate of Girls Hostels to E-Type Staff Quarters Block (E-13 to E-16) including path to P.H.E Tube well at lower Residential Area of New University Campus, University of Jammu, Jammu. (Estimated Cost 6.41 Loc)

Resolution: The committee after deliberation approved the said project in principle and recommended the expenditure for execution of this project out of the infrastructure fund of the University subject to the concurrence from Infrastructure fund committee.

The meeting concluded with vote of thanks to the Chair.
