 The University prepares short term and long term plans for its immediate and long terms requirements. The Development Section invites proposals from different Departments/Sections/Offsite Campuses regarding their future plans. The said proposals are placed before the Planning Board/ Works Committee/ Building Committee for scrutiny and evaluation of the proposals. The proposals which are approved by the Committees or Planning Board are placed before the requisite statutory bodies of the Universities or submitted to the State Government / UGC or any other funding agency with Detailed Project Reports for seeking financial assistance. Once the physical Infrastructure is created it is handed over to the concerned section/Department for optimal utilization. Laboratory Record of maintenance account is maintained by the laboratory assistants and supervised by Heads of the concerned Departments. The maintenance of laboratory equipments is done from time to time by the concerned staff. The University has a Library Committee which has the power to suggest measures for the development and improvement of the functioning of the library and monitors the overall working of the library. It sanctions the budget grant for purchase of books and journals and/or any other equipment required for the Library to enforce Library Regulations etc. • Students are encouraged to register themselves in library to use INFLIBNET. RFID with TAGSYS , a special feature of the Libsys software for anti -theft which is installed in the Central Libarary, thus keeping a check on the circulation of the resources of the library. • Suggestion box is installed in in each Departmental library/Central library. • Visitor book is maintained in each Departmental library/Central library of the University. • To ensure return of books, 'no dues' from the library is mandatory for students before appearing in exam

6.1.1 – Mention two practices of decentralization and participative management during the last year (maximum 500 words)

a) Based on the NAAC grade and upon being conferred as a Category 1 University with full autonomy by the UGC, the University of Jammu has been selected for a grant of Rs.100 crores under the RashtriyaUchchatarShikshaAbhiyan (RUSA -II) in 2019 for enhancing quality and excellence and Faculty Improvement. To prepare the plan proposals and allocate funds to differentdepartments/centres/campuses, the University followed the practice of participative management by following a consultative process wherein all Heads of Departments, after discussing it in their Departmental Affairs Committee, made presentations of their plans for financial assistance under RUSA -II. On the basis of inputs from these departments/centres/campuses, the University achieved few benchmarks like -Development/Up-gradation of Sports Facilities at New University Campus - 1st Advisory Committee meeting was held with eminent experts from all over the country invited to take up the thrust areas of research - 129 Research Scholars selected for RUSA Research Fellowship - Research Grant provided to 47 Professors/Associate Professors for Undertaking Innovative Outcome Based Research - Seed Grant provided to 49 Assistant Professors For Writing / Submitting Outcome Based Research Projects Focusing on Real World Issues -Creation and Promotion of Innovation Ecosystem in the University -Establishment of Institution Innovation Council (MHRD) - Creation of 07 Research Clusters in the University Thus the plan proposals and allocation of funds to various departments under the prestigious RUSA grants were decided in the mostparticipative and decentralized manner. b) Celebration of Golden Jubilee Year of the University: The University of Jammu has completed 50 years of its establishment in September 2019. To commemorate the golden jubilee celebrations, the University organized array of activities ranging from special benchmark lecture series, academic events to sports and extra curricular activities and competitions, developed souvenirs, prepared promotional Documentary on University of Jammu, prepared Coffee Book table etc. For these activities, separate committees were constituted comprising of heads of departments, faculty members and administrative staff. A core committee headed by the Vice Chancellor to finalize all the activities/events was constituted. Thus the jubilee year celebrations witnessed participation from a majority of stakeholders of the University.

In order to bring the curriculum at Curriculum Development par with the best institutions/universities of the country, the University organized various Seminars / Conferences/ Lectures by different departments under various themes at National / International level. The University purchased Equipments and books in different disciplines as per revised curricula. From the ensuing academic session 2019-20, SWAYAM courses have been made mandatory and all students enrolled need to register for at least a 2 or 4 credit course, over and above the minimum credit requirement for a programme. 1) TITLE OF THE PRACTICE: Promotion of Culture of Innovation and Incubation at University of Jammu CONTEXT AND PRACTICES In order to promote a culture of Innovation and Incubation, the University of Jammu established the University Business Incubation and Innovation Centre (UBIIC) and Institution Innovation Council (IIC) sanctioned by Ministry of HRD, Government of India. The objectives of the established centres are: • To create a vibrant local innovation ecosystem and foster an entrepreneurial culture at the University level. • Establish function ecosystem for scouting ideas and pre incubation of Ideas. • To facilitate the availability of resources to the incubatees in a mutually beneficial way. • To create startup supporting mechanism for the students of Jammu and Kashmir and provide a conducive working environment to the incubatees to nurture their innovative ideas. • To build a vibrant startup ecosystem, by establishing a network between academia, financial institutions, industries, and other institutes. The UBIIC and IIC, University of Jammu endeavor to bring out the innovation potential of the students, research scholars and faculty members and encourage out of the box thinking. Under the ambit of UBIIC and IIC, University of Jammu, several activities have been planned to be organized like Ideathons, seminars, workshops, elevatorpitch sessions, startup meets, lecture series, community engagement activities, training and mentorship programmes. Working with a close industry academia government connect, it aims to support the budding entrepreneurs and innovators

by providing them a facilitating learning environment and build a robust startup ecosystem that is strengthening and driving the orientation of individuals from job seekers to job creators. EVIDENCE OF SUCCESS Since its inception, several activities and initiatives have been undertaken by UBIIC and IIC to reach out to maximum students, research scholars and faculty members and encourage towards innovative thinking. Some of events undertaken during the period include:- • Workshop on Entrepreneurship and Innovation • Invited Talk on "My Story- Entrepreneur's Life and Crossroad • Lecture on "Innovation Amidst Adversities'' under the Innovation Roadmap Programme • Launch of Kapila: Kalam Programme for IP Literacy and Awareness and Inauguration of the Intellectual Property Literacy Week organized by MHRD, Govt. of India to be attended by all IICs. • Smart India Hackathon 2019 (MHRD, AICTE, i4c and Persistent system successfully organized the second edition of Smart India Hackathon 2019) PROBLEMS ENCOUNTERED RESOURCES REQUIRED The major challenge faced has been to encourage widespread participation of students across discipline especially the non science students. To overcome the challenge, IIC and UBIIC is laying thrust on Social Innovation area. For extensive promotion of innovation and incubation in University, both financial and infrastructural support is also being sought. 2) TITLE OF THE PRACTICE: Establishment of Special Purpose Vehicle (SPV), a Section 8 company under Companies Act, 2013 CONTEXT AND PRACTICES University of Jammu established the University of Jammu SPV Foundation, a section 8 company in 2019 with an objective to implement and execute various new initiatives of University of Jammu. Through the SPV, University of Jammu aims to implement the grants received under RUSA 2.0, seek consultancy projects from various government agencies, apply for grants from NITI Aayog and related activities. Till date, UoJ SPV Foundation has supported the initiatives of UBIIC and IIC, University of Jammu. Some of the events undertaken through UoJ SPV foundation include • Launched Parivartan - A Start Up Ideathon during September 2019 with an objective of inviting business ideas revolving around social issues /problems in Jammu Kashmir. • Lecture by Sh. Sonam Wangchuk on the theme 'Innovation amidst Adversities', November 01, 2019 under the Innovation Roadmap Programme. • Applied for Atal Community Innovation Centre (ACIC) under Atal Innovation Mission EVIDENCE OF SUCCESS Since its inception, several activities and initiatives have been supported by UoJ SPV Foundation. Further to strengthen the activities through UoJ SPV foundation, the proposal to hire Young Professionals was approved by University of Jammu. The first phase of selection process has already been completed and the YP's selected shall soon join the team. PROBLEMS ENCOUNTERED RESOURCES REQUIRED Since UoJ SPV Foundation is still in the nascent stage, the major challenge faced is the availability of manpower for effective implementation of the plan. Further UoJ SPV is at present operating from existing teaching department, once the space allocated to SPV foundation is made available, more efforts shall be undertaken by the company.

The University through these centres endeavours to provide a facilitative environment and build a robust startup ecosystem to motivate and orient students to become job creators instead of job seekers.
