# **Expression of Interest (EOI)**

Directorate of Distance Education (DDE), University of Jammu intends to establish 2 no. of Digital Studios with Recording and e-resource creation facility at DDE, University of Jammu on turnkey basis.

The objectives of this EOI are as under:

- 1. Development of state-of-the-art recording studio with storage and archiving facility at DDE, University of Jammu.
- 2. The purpose of digital audio video recording studio is to facilitate live lectures as well as to record academic lectures of Senior Officers, Guest Lecture, Academia, Panel discussions and demonstrations . The audio video recorded file will be used for students undergoing different courses in University of Jammu.
- 3. The purpose is to create digital/e-resource for use of faculty, students and other stake holders.
- 4. To identify suitable firms for design, development, implementation and maintenance of this studio on the turnkey based project which would also include supply, installation, testing, commissioning, training, operationalization and technical support for infrastructure, technical equipment and software.
- 5. The faculty will be housed in the premises of Directorate of Distance Education, University of Jammu, J&K.
- 6. The EOI invitation is on a non-committal basis. Thereafter, at second stage, bidding may not be restricted only to shortlisted vendors of EOI stage and subsequently E-procurement procedure as per GFR shall be followed.
- 7. Presentation should focus on plan layout, interiors, technical requirements etc.
- 8. The tentative date for presentation shall be in the first week of September in the Office of the Directorate of Distance Education (DDE), University of Jammu.
- 9. The Vendor should submit a document indicating all the equipments & other accessories with detailed specification necessary for the establishment of Digital-cum-recording studios as per the presentation.
- 10.2 Digital studios (1<sup>st</sup> at Ground Floor and 2<sup>nd</sup> at First Floor) with waiting area space in the Ground Floor & storage area & other allied apartments required for this purpose.
- 11.No sublet of the work shall be allowed
- 12. Manpower for operationalization of the Studios for a period of 1 year.

Firms including interested OEM, authorized distributors/ or Company dealing with such nature of work and fulfilling the following Pre-Qualification Criteria may submit their EOI duly enclosing product brochure, detailed budgetary quote and other connected documents. The concerned firms may also send their comments on objective and scope of the equipment projected in the enquiry. The firm are also required to provide details of the capabilities to undertake the installation & maintenance of subject equipment keeping in future requirements.

#### **1. PRE QUALIFICATIONS CRITERIA**
