OR (iv) Bachelor's degree and having participated in National/Inter University / State competitions or secured 1st, 2nd or 3rd position in Inter College / Inter-Zonal/ District/ School competition in sports and games as recognized by the AIU/IOA/SGFI/Govt. of India. OR (v) Bachelor's Degree with participation in International competitions or secured 1st, 2nd or 3rd position in National/Inter-University competition in sports and games as recognized by respective federations/ AIU/ IOA/SGFI/Govt. of India. OR (vi) Graduation Degree and at least three years of teaching experience (for deputed in service candidates i.e., trained physical education teachers / coaches). The persons with disabilities are not eligible for admission to the programme. The candidates qualifying the written exam test shall have to further appear in the Physical Fitness Test to be conducted by the Department of the Physical Education, University of Jammu. The number of candidates to be invited for appearing in the Canadian Test shall not exceed three (3) times the number of seats available in the Directorate. The selection for admission shall be made on the basis of composite merit obtained in the Entrance Test out of those qualifying the Canadian Test.	500

IMPORTANT GUIDELINES FOR COUNSELLING/ ADMISSION:

- 1. All the applicants Appeared/Not Appeared in CUET-PG-2024 are eligible to apply.
- 2. The applicants appeared in the CUET-PG-2024 will be given first preference for admission and the Non-CUET applicants will be considered under second preference.
- 3. CUET-PG-2024 applicants will be allocated seats on the basis of CUET-PG-2024 score whereas the Non-CUET applicants will be allocated seats on the basis of the academic merit of their qualifying examination.
- 4. The applicants have to apply for PG Admission, within a stipulated time, and must have passed the qualifying Bachelor's Degree Examination (Honours or General or a qualifying examination of a professional degree of not less than 3 years duration or any other examination recognised as equivalent thereof), from a recognised university/institution with at-least 50% of the aggregate marks. SC/ST applicants with 45% for aggregate marks can also apply.
- 5. All the admissions shall be PROVISIONAL till such time the same are verified/ regularized by the University. No document/ certificate shall be accepted by the Nodal Department/ College after the last date. Admission shall be made through online Counseling on the basis of the preferences/choices given by the candidate on the online admission form.
- 6. Filling up of the Online Admission Form is mandatory and pre-requisite for Admission. The Candidates are required to fill the same carefully as per the Statutes. The University will not be responsible for any mistake/ lapse on the part of the Candidate while filling up of the Online Admission Form.
- 7. In case of B.Ed 75% of the total allocated seats are reserved for Domicile candidates and 25% for Non-Domicile candidates for each affiliated College.
- 8. FEE & MODE OF PAYMENT:- Registration Fee, for admission, to be charged from each applicant and mode of payment is online only (Net Banking / Credit/Debit Card etc.) The applicant can check his/her status of payment after login to his/her account on the admission portal. In case of M.Ed the candidate desirous to be considered for SELF-FINANCING seat has to pay an additional fee of Rs.730/- which has to be paid at the time of filling up of the Admission Form. A candidate who does not opt for the Self Financing Seat/s at the time of the filling up of the Online Admission Form along with the requisite fee will not be considered for Admission under the Self Financing Seat/s at later stage.
- 9. No 'UNDER PROCESS CERTIFICATE' will be entertained under any circumstances for Admission under any Category.
- 10. For Reserved/Achievement Categories, the applicant has to upload Self Attested copy of the Domicile Certificate along with Reserved/Achievement Category Certificate/s issued by the competent authority as per Annexure-B.
- 11. A Candidate, seeking admission under any Achievement Category (i.e. Sports, Cultural & Literary Activities, NCC, NSS and Bharat Scouts and Guides) is required to upload all the achievement category certificates for evaluation. Achievement Certificate/s not uploaded online at the time of filling of online admission form will not be considered for evaluation at later stage.
- 12. A Candidate selected for Admission under any Reserved/ Achievement Category has to keep ready the Original and Self Attested Copies of the Domicile Certificate as well as the other relevant Reserved Category Certificate/s as required and as issued by the Competent Authority. Such a Candidate is required to submit these certificates to the concerned Department/ Nodal Department for verification on the date as notified for the purpose. The admission of such candidate is subject to verification of the ORIGINAL certificates by the Members of the Admission Committee of the concerned Department/ Nodal Department.
- 13. All the applicants applying for admission are required to submit an undertaking in the form of an affidavit as per **Annexure-A**.
- 14. In respect of the Admissions to the Campuses/Affiliated Colleges, the Nodal Department/s will charge the University fee and other fee, as the case may be, shall be charged directly by the respective Campus/Institute / College.
- 15. The Admission of a Candidate supplying incorrect/factually wrong information in the Online Admission Form will not be considered for admission and is liable to be cancelled at any stage.

- 16. The Applicants after successful completion of registration of the online admission form are advised to keep a print out of his/her Application, copy of fee receipt for any future reference.
- 17. No separate intimation for Counselling or Admission shall be sent individually to the candidates. Candidates are advised to be in continuous touch with the University website for latest updates.
- 18. All the candidates, who have already filled online admission form <u>need not to apply afresh</u>. However, these applicants can FILL FRESH PREFERENCE by login to their account.
- 19. It will be mandatory for the candidates to present in person in the Nodal Departments/B.Ed College for Counselling/ Physical Verification/ Admission with original documents. Failure to do so will forfeit the candidate's right to seek admission to the programme.
- **20.** The provisional admission will only be confirmed after the successful remittance of the Admission Fee. Merely applying and appearing for Physical Verification/ Counselling does not confirm admission.
