The Syndicate members were of the considered opinion that the cut-off date i.e. 19.06.2014 seems to be unjust and unfair as it was mentioned keeping in mind the cut-off date in respect of the employees of SKUAST and, therefore it was resolved in principle that the stepwise Career Advancement Scheme in respect of Sr. Technical Assistants and Equivalents be also granted to situated employees of the University of Jammu appointed after 19.06.2014, in light of point no.-iii under Notes of Notification No. 16 (Secy.) of 2018 dated 11.07.2018 issued by SKUAST, Jammu.

As in the absence of Financial Advisor (Universities) the final decision could not be taken therefore, it was resolved that the matter with full facts and justification be referred to the Financial Advisor (Universities) for formal concurrence.
