- 3. The License has to be generated on the Name of Director, The Business School, University of Jammu, Jammu
- 4. Firm shall be required to submit complete information/brochure/catalogue of the product along with the offer (if any).
- 5. In case company/firm is registered with GeM/ any other Government organization/ undertaking; should be clearly mentioned.
- 6. The quotation should be on the letter head of the firm duly signed with reference no. and date.
- 7. **ON-SITE Installation charges** should be mentioned separately in the financial bid. The installation has to be done by the firm in person at Jammu in the premises of The BUSINESS SCHOOL, UNIVERSITY OF JAMMU, JAMMU.
- 8. Quotation must be in accordance with our specifications otherwise it will not be accepted.

Bidders who are not meeting any of the below mentioned general, technical or commercial criteria and not furnishing the requisite documents along with their bid shall be disqualified straightway and their bids shall not be considered for award of work.

1.3	The Bidder should not have been blacklisted/debarred by the Government of India or their undertakings, any State Governments or their undertakings during last 3 years. In such cases the bid will be summarily rejected and no correspondence in this matter shall be replied by the University.
