globe to ensure that the students are able to gain knowledge and help professionalise the country's foreign trade management and increase exports by developing human resources; generating, analysing and disseminating data; and conducting research. Even the faculty at the International Centre is engaged in conducting path-breaking research in this specialized area and have been publishing with journals of national and international repute contributing towards the overall growth and fame of the International Centre at the regional/national and international level. The MBA-International Business Programme is the most sought-after standard of postgraduate-level degrees. Strengths:

1. Academic Profile:

ICccR & HRM is the only Academic Unit which is specifically catering to the International Business, Cross-Cultural and International Human Resource Management / Development dimensions /specializations in the State of Jammu and Kashmir.It is the pioneer Academic Centre in the State of Jammu and Kashmir (J&K) to offer academic programmes which include MBA-International Business (MBA-IB), Post-Graduate Diploma in 'Composite Culture Management', besides Certificate Courses in Cross-Cultural International Management, Human Resource Management and Labour Laws and new courses in Business Communication Skills and Entrepreneurial and Project Management Skills, as add-on opportunity which enables the students to gain knowledge in the broader domain of International Business in the light of globalization.

2. International Profile:

ICccR & HRM has competitive advantage in these areas and the Centre is essentially contributing to the International profile of University of Jammu.

3. Publications:

The faculty and staff at ICccR & HRM are highly dedicated and hard working and contribute to the stature of the department by **publishing across a wide spectrum of domains** like cross cultural management, international business, technology transfer, work value across cultures, entrepreneurship, HRD, leadership, ethical issues etc. in reputed national and international journals and books.

4. Collaborations:

The collaborations that the International Centre is entering is clearly indicative of the scope of activities that is enhancing at ICccR & HRM to justify the international/interdisciplinary nature of the programmes offered at the International Centre.

5. Student-Centric Approach:

Weaknesses

- 2. More faculty members need to be recruited on a permanent basis.
- 3. Space not sufficient as on date, though centralized facilities are used to address this deficiency. Also, the process of adding up new building is in progress.

Opportunities

1. The training that the students gain in the domain of International Business opens up their doors for career opportunities in several multinational corporations.

Challenges

- 1. To make students realize the growing importance of international business and globalization in today's business environment and the relevance of sectoral MBAs.
- 2. Due to the self-financing nature of the MBA-IB Programme offered at ICCCR & HRM, the financial constraints affect student intake at times.
- 3. Limited number of opportunities in the State of J&K to absorb (in terms of placement opportunities) the students specializing in International Business.
- 4. Acceptance issues in the Administrative set-ups and other similar departments in the University.

- 1. The International Centre aims to create opportunities for employability as well as research that addresses the current global and international business issues and contexts. Subsequently, with the beginning of the **PhD Programme at ICccR & HRM**, the research base shall further be strengthened and **cross cutting research** shall be undertaken at the International Centre wherein eminent and significant research issues shall be catered to.
- 2. The International Centre not only aims to train students to become professionals but also endeavours to connect them with the various clusters of society who shall ultimately work as corporate leaders serving the communities and various stakeholders in the process. Thus, through its **collaborative initiatives** the International Centre shall not just bring home corporate exposure but also corporate social responsibility through its extension and outreach initiatives that are already taking shape at ICccR & HRM by joining hands with NASSCOM, etc.
- 3. The International Centre for Cross Cultural Research and Human Resource Management (ICccR & HRM) is actively engaged in planning and designing for upcoming Workshops/ Seminars/Conclaves and Panel Discussions on the themes that would be focusing on achieving below mentioned objectives:
 - Promotion of understanding and awareness of International Management and Cross-Cultural contexts, seen as cardinal and essential for promoting international cooperation, collaborations and business ties in the region and the State.

- Promotion of education, collaborative research and consultancy in the area of International Management, Cross-Cultural Management and International Business.

Besides, the department has upgraded its teacher education curriculum (B.Ed. & M.Ed) to two years on All India pattern on the recommendations of Justice Verma Commission and the curriculum is not only upgraded but is one of the best curriculum in teacher education not only in India but also at the International standards. For it, the workshops were held and many more academic workshops are likely to be held to orient the teacher educators on the emerging areas and themes.

Challenges

As the new teacher education curriculum is in vogue, it is most daunting task for the department in general and faculty in particular to equip the prospective students with the complete programme. Besides, it is a great challenge for the faculty to orient all such students who come from other faculties under the open courses and to bridge a linkage in the academic knowledge between two diverse streams.

Need of the Experimental/Practising school

As per the Justice Verma Commission recommendations and duly approved by the University Council wherein the every teacher education institution need to have its own experimental/practising school, the Department of Education being a nodal department does not have any practising school at present of its own. So, a plan is to be mooted wherein a school is to situated within the Department, so that the teacher trainers needs could be fulfilled. So it is needed that a separate spacious building of the Department may be planned wherein mentioned required infrastructure along with the practising school can be possible.
