NOTIFICATION

This is in continuation to earlier notification No. Admission/25/875-974 dated18-08-2025and owing to the change in the eligibility criteria with respect to the admission in Semester-7th (Honours) as discussed in the Standing Committee of the Academic Council, It is hereby notified for the information of all concerned that the admissions to Semester-7th (Honors/Honors with Research) of Four Year Under Graduate Programme under National Education Policy(NEP)-2020 in all Govt. and Non-Govt. colleges affiliated to the University of Jammu is extended as per following schedule:-

a) 20-08-2025 to 13-09-2025

(without late fee)

b) 15-09-2025 to 24-09-2025

(with late of Rs.420/-)

c) The Vice-Chancellor may consider grant of the late admission for 10 days after the expiry of last date of admission on payment of late fee of Rs. 3520/- subject to the condition that wherever income of a candidate's parents is below poverty line (BPL) he/she be exempted from the payment of Rs.3520/-. However, late fee shall be charged in such cases as prescribed at (b) above.

Eligibility Criteria:

For Students:-Candidates having backlog of not more than 50% credits upto5th Semester shall purse Honors Degree whereas, only those candidates who have successfully completed 6th semesters with 75% marks and above shall be allowed to continue Fourth Year of the Undergraduate Program to obtain the Bachelor's Degree (Honors with Research), if the candidate is interested.

For Designating Research Project Guides:- All Ph.D qualified faculty members with at least two published papers to their credit & serving in the substantive capacity shall be designated as Research Project Guides for Research Project under FYUGP.

For Colleges:-

Infrastructure requirement:- The Departments offering a 4-year UG Degree (Honours with Research) must have the required infrastructure such as the library, access to journals, computer lab and software, laboratory facilities to carry out experimental research work and at least two permanent faculty members who are recognized as Ph.D supervisors. The Departments already recognized for conducting the Ph.D programme may conduct a 4-year UG programme (Honours with Research) without obtaining any approval from the affiliating University.
