 - 5. Treasurer (one)*
 - 6. Publicity Secretary (one)
 - 7. Executive Members (Six)

*UJAA Life Members working in the main campus of University of Jammu are only eligible to contest as per clause 9.1.1 i.e as follows:

"All the office bearers and Executive members of the UJAA shall be elected by the General Body for two years. However, for the position of Secretary and Treasurer only members working in the main campus of the University of Jammu shall be eligible to contest".

Who will contest?

Clause 9.2.3 Eligibility Criteria for contesting EC elections:

Only the Life Members of the UJAA are eligible to contest for any of the positions in the EC, including office bearers. In any election an alumnus can contest for only one post.

Who can cast the vote?

The alumnus who registers as Life Member of UJAA till 30-11-2025 (i.e. pays the Life Membership fee to the bank account of UJAA by 30-11-2025)

General Instructions:

- 1. The voter who shall cast his/her vote at the polling booth are required to carry the valid identity proof.
- 2. Tie at any position shall be resolved by draw of lots.
- 3. Any kind of negative campaign/canvasing that may affect, directly or indirectly, the image/perception of the University of Jammu, shall amount to cancellation of the life membership/candidature of the contesting candidate.
- 4. No TA/DA shall be given to any life member who shall come for casting his/her vote at the polling booth.
- · 5. The given schedule of elections shall be strictly followed without any prejudice.
- 6. In case of any dispute, the decision of the Returning Officer in consultation with Assistant Returning Officers and Observers shall be final.
- 7. The Venue of the Elections is Committee Room, Centre for Distance and Online Education(CDOE), University of Jammu, Jammu.
