# Filing of Appeals for Admissions to the PG Programmes (Academic Session 2021-22)

This is for the information of all concerned that in case a candidate, who has filled his/her online Admission form in time, paid the requisite fee, has any grievance and feels that the Statutes governing admissions have not been adhered to, he/she may make an appeal on the Form prescribed for the purpose and remit the <u>requisite fee of</u> Rs. 440/- (Rupees Four Hundred Forty only) w.e.f. 14-01-2022 to 19-01-2022.

The applicant can download the Appeal Form from the JUET Website <a href="www.juetonline.in">www.juetonline.in</a> All the requisite details are to be filled in by the applicant in his/her own handwriting. The applicant who desires to prefer an appeal will have to submit the Appeal Form(s) to the concerned Head(s) /Director(s) /Nodal Department(s) along with all the requisite documents and fee receipt.

- Only genuine grievance where Statutes governing admission have not been adhered to will be accepted. Incomplete and spurious appeals will not be considered.
