Subject: Disposal of e-waste.

Sir/Madam,

The University of Jammu vide notification no. Estab/23/18044-63 dated 23.11.2023, has constituted a committee for e-auction of the e-waste lying in the various Departments / Sections of the University of Jammu for which a one-time consolidated tender is being prepared.

In this context, all the Heads of the Departments/Directors of various Centres/Director, DDE/Controlling Officers of various administrative sections/officers/Administrator, University Auditoriums/Officer Incharge, University Guest House & Transit House and Wardens of University Hostels, are requested to provide information as per performa enclosed (Annexure-I) in light of the e-waste policy, **on or before 08.12.2023** in the Office of the USIC, University of Jammu. The cut-off date for declaring the various items as e-waste is as per list enclosed (Annexure-II).

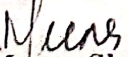
It is pertinent to note that:

1. Information received after 08.12.2023 shall not be entertained by the Committee for inclusion in the consolidated e-auction. Thereafter, Departments / Sections shall be responsible for disposal of the same on their own.
2. The concerned HODs / Controlling Officers / Branch Officers etc., shall ensure that the information provided is duly verified and vetted by the concerned Departmental Affairs Committee / Local Purchase Committee / Services Section etc.
3. The HODs / Controlling Officers / Branch Officers etc., shall ensure that the e-waste is segregated as per performa and placed at a convenient spot for inspection by the prospective bidders.
4. The onus for writing-off of the auctioned e-waste from their respective stock registers, after its removal from the Departments / Sections, shall lie solely with the concerned HODs / Controlling Officers / Branch Officers etc.
