In continuation to the Government Order No. 232-F of 2023 dated 12.12.2023, it is hereby ordered that Government Employees working regular in pay levels under 7th Pay Commission recommendations shall be paid Dearness Allowance as under:-

Existing Rate of DA per month	Revised Rate of DA per month	With effect from
46% of Basic Pay	50% of Basic Pay	01.01.2024

- (i) The term 'Basic Pay' in the revised pay structure means the pay drawn in the prescribed level in the Pay matrix as per 7th Pay Commission recommendations, but does not include any other type of pay like special pay etc.
- (ii) arrears on account of additional installment Dearness Allowance with effect from January, 2024 to April, 2024 shall be paid in cash in May, 2024 and shall form part of monthly salary from May, 2024 onwards.
- The payment on account of Dearness Allowance involving (iii) fraction of 50 paisa and above shall be rounded to the next higher rupee and the fraction of less than 50 paisa shall be ignored.
