As we all know that Ragging has become deep-rooted problem especially with the rising number of incident in Higher Educational Institutions, due to which many students fall prey to it, give up their studies or even take extreme steps. Therefore, keeping this in view and to curb the evil practice of ragging, you are requested to constitute a DEPARTMENTAL ANTI RAGGING COMMITTEE, comprising of the Faculty Members, Staff, Departmental Representatives of the Research Scholars, Class Representative(s) & other senior students of your Department with an intimation to this office.

The members of the said committee be requested to remain present in the Department, during the working hours and move in and around the Department from time to time so that such incidents of ragging do not take place at all.

It is, further requested that a prompt and strict action be taken immediately as and when such a case is brought to your notice. Senior students may also be briefed regarding the strict measures to be taken in such matters.

Further, it is also suggested that "WELCOME PROGRAMME" or "FRESHERS' DAY" be arranged, involving Teachers, Senior Students and the new comers so that the senior students and the new comers could exhibit their talent on a common platform and interact with each other in a congenial atmosphere.

The telephone Nos. of the authorities to be contacted in case of an incident of Ragging (copy enclosed) and same be displayed on the Departmental Notice Board and other prominent places within the Department. The students be allowed free access to the phones (Cell Phones No. and Land Lines) in Hostels for timely reporting. You are also informed that Anti Ragging Toll Free Helpline has been made operational by the UGC. The status of the helpline is as under: -



# BAN ON RAGGING

## ADMINISTRATIVE ACTION IN THE EVENT OF RAGGING

- ◆ Suspension from attending Classes and Academic privileges.
  - ◆ Withholding of Scholarship/Fellowship and other benefits.
  - ◆ Debarring from appearing in any Test/Examination or other Evaluation process.
  - ◆ Withholding Results.
  - ◆ Debarring from representing the Institution in any Regional, National or International Meet, Tournament, Youth Festival, etc.
  - ◆ Suspension/Expulsion from the Hostel.
  - ◆ Rustication from the Institution for period ranging from all Semesters.
  - ◆ Cancellation of Admission.
  - ◆ Expulsion from the Institution and consequent debarring from Admission to any other Institution for a specified period.
  - ◆ Filing of First Information Report (FIR) with the Police & Local Authorities, under the appropriate Penal provisions.
- Provided that where the persons committing or abetting the act of Ragging, are not identified, the University shall resort to collective punishment.
