Instruction for employees bypassing proper channel for redressal of grievances - reg.

## Circular No.38-JK(GAD) of 2021 Dated:20-09-2021

It has been observed that some officers/officials working in various Government Departments of the Union territory of Jammu and Kashmir are bypassing proper channels and approaching higher offices viz. that of Hon'ble President's Secretariat, Hon'ble Prime Minister's Office, Hon'ble Lieutenant Governor's Secretariat and the Office of the Chief Secretary, for redressal of grievances pertaining to service matters. These acts being in violation of the Jammu and Kashmir Civil Services Conduct Rules, 1956 have been viewed seriously by the authorities.

Accordingly, it is enjoined upon all employees working in various Departments/Organizations to desist from approaching such offices henceforth, follow the prescribed procedures and approach the appropriate authorities for redressal of their genuine grievances. Any violation of these instructions by any employee shall invite strict disciplinary action under Rules.
