Pay of the above incumbents will be fixed under the provisions of the Jammu & Kashmir Civil Services (revised pay) Rules, 2018.

The incumbents placed in the 1<sup>st</sup> step shall be eligible to exercise their option to avail of the promotional benefits (non-functional) immediately after the date of placement in the 1<sup>st</sup> step or defer the same following the date of next annual increment. Such incumbents shall communicate their options in writing to the Establishment section-NTW

within a period of the one month from the date of issuance of order. The option once exercised shall be treated as final.

The employees placed in the 1st step shall continue to hold their designation till such time they are promoted subsequently against the higher post in their respective category. In that case, their designations shall be changed and the  $\mathbf{1}^{\text{st}}$  step scale held by them in their personal capacity shall be declared substantive from the date of such promotion without any change in their pay being drawn in the said scale.
