## NOTIFICATION

Pursuant to the Resolution No. 88.51 of 88th University Council Meeting held on 30.12.2024, following framework is hereby notified for promotion from Professor to Senior Professor (Academic Level-15) under Career Advancement Scheme (CAS) of University Grants Commission (UGC):

- 1. Candidates applying under UGC Regulations On Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for The Maintenance of Standards in Higher Education, 2018, dated 18th July, 2018 will be assessed as per the provisions laid down in these Regulations. On successful assessment and fulfillment of the conditions laid down for promotion as Senior Professor (Academic Level-15) in these Regulations, the candidates will be designated as Senior Professor with effect from 18.07.2018 or their date of eligibility, whichever is later.
- 2. Further UGC Regulations 2018, dated 18th July ,2018 vide clause 6.3 as amended by 4th amendment of UGC Regulations 2024 dated 6th June, 2024 also provide an option to the applicants for being considered for promotion under Career Advancement Scheme 2010 for promotion as Professor (Stage 6) or Career Advancement Scheme as laid down in UGC Regulations 2018, dated 18th July, 2018 for promotion as Senior Professor (Academic Level-15) respectively.

The applicants opting for the UGC 2010 shall be assessed as per the provisions of the UGC 2010 guidelines and their date of eligibility shall be retained provided they fulfill minimum eligibility conditions laid down under these Regulations. Further, such candidates shall continue to be designated as Professor (Stage-6) as per clause 6.4.10 of UGC Regulations 2010.

In case such an applicant seeks to be designated as Senior Professor, the applicant/s will have to apply afresh under the provisions of UGC Regulations 2018, dated 18th July and shall be assessed according to these guidelines. Such candidates would be designated as Senior Professor on 18-07-20218 or date of eligibility whichever is later on successful assessment following the due process prescribed for the same as per UGC Regulations 2018, dated 18th July, 2018.

3. Further in consideration of clause 6.3.9 of UGC Regulations 2010 and clause 6.3(V) of UGC Regulations 2018, the applicants who are no longer on the roles of the University, cannot be considered for promotion.
