





Higher Education Department:

1. Number of Awards: 10

- a) 08 for College Teachers (04 each for Jammu and Kashmir Divisions)
- b) 02 for University Teachers (01 each for Jammu Division and Kashmir Division)

2. Prize:

A Silver Medal-(40 gm), Certificate and Rs. 50,000/- as the award money. Each Award shall be given annually on Teacher's day i.e. 5th September.

3. Eligibility:

Following teachers shall be eligible for these awards:-

- i) Teachers working in Government / Private Colleges (Undergraduate, Engineering, Architectural and Nursing Colleges) and all Universities (including aided Universities) of J&K UT.
- ii) Teachers with minimum 10 (ten) years teaching experience in regular service.
- iii) The candidature should be recommended by the Principal of the concerned College/ Registrar of the concerned University.

4. Criteria Points:


Teachers shall be evaluated based on the evaluation matrix given at **Annexure-C**. The Evaluation matrix contains two types of criteria:-

1. Objective criteria:-

The teachers shall be awarded marks on objective criteria by the Head of the Institution (HOI) criteria based on special performance e.g. punctuality & regularity of the teacher, teaching based on well defined student feedback.

2. Performance Criteria:-

The Performance based criteria shall be evaluated by the Internal Quality Assurance Cell (IQAC) of the Higher Education Institution (HEI) on the criteria such as, details regarding Ongoing research Projects, Research Publications, Membership of different academic bodies like BOS/BORS/Academic Council/ Scientific, Development of E-Content, Awards and Medals received in last five years, initiatives to improve learning outcomes, innovative experiments undertaken, organization of extra and co-curricular activities, use of teaching learning Material, Social mobility, ensuring experimental learning etc. These criteria are assigned the weightage of 100 marks. The evaluation of these performances shall be supported by the relevant documents.



5. Application Procedure:

- a) All the applications as per the prescribed format shall be received through an online web portal.
- b) The Higher Education Department shall ensure coordination with all higher educational institutions regarding timely data entry into the portal and the resolution of technical and operational issues through the portal Development Agency.
- c) Each applicant shall submit a portfolio through online mode alongwith the Entry Form. The portfolio shall include relevant supporting documents.
- d) Each applicant shall submit an undertaking through online mode stating therein that all the information/data submitted is true to the best of his / her knowledge and if found false or incorrect, he/she shall be liable for disciplinary action.

6. Selection Procedure:

Stage-I: The following two Screening Committees, comprising the following, shall scrutinize the applications of Teachers from Universities and Colleges in the two Divisions of Union territory of J&K:





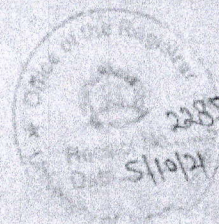
