Meeting of Board of Studies in Nursing was held on 14-06-2024 in the office chamber of Dean, faculty of Medical Sciences, GMC, Jammu. The agenda items discussed are given below.

1. **Discussion and consideration of the synopsis of 17 students pursuing M.Sc.(N) - 1st year, session 2021-22.**

The committee members considered, and approved the synopsis of 17 students (Annexure- A) and resolved that the submission of the final thesis should be submitted within 6 months period.

2. **Discussion and consideration of the synopsis of 05 students pursuing M.Sc.(N) - 1st year, session 2022-23.**

The committee resolved that synopsis of the five students cannot be considered, in the absence of meeting the benchmark criteria of attendance, the delay cannot be condoned as there can be no relaxation on medical grounds in areas of research.

3. **Review and discussion of proposed syllabus of M.Sc (N) in forensics for the academic session 2023-24.**

The committee evaluated the proposed Syllabus of M.Sc.(N) in forensics and approved the same to the university. (AnnexureB)
