

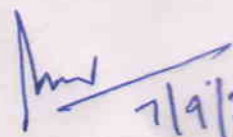

ADMISSION FEE of the PROVISIONALLY ADMITTED applicants during Special ON-SPOT Round shall be accepted by the Nodal Departments through Electronic transfer only (NEFT/ UPI/ Net Banking). Nodal Departments will share their Bank Details (Name of Bank/ A/c No/ IFSC Code etc) with the admitted applicants for taking admission fee. NO CASH/ CHEQUE/ DRAFT shall be accepted for Payment of Fee.	

NOTE:

- Details of the VACANT SEATS shall be notified by the Departments/ Nodal Departments on their website <https://jammuuniversity.ac.in/academics/faculties>. To access details, visit the University Official website and follow the path given below:
ACADEMICS → FACULTIES → (Select Department) → ANNOUNCEMENT OR ADMISSIONS
- Candidates, who have already filled online admission form and Not Admitted to a programme in the previous rounds shall be considered under **FIRST PREFERENCE** and only after exhausting list of the earlier applicants the fresh applicants shall be considered for admission under **SECOND PREFERENCE**.
- Admissions shall be made on the basis of the Score/ Marks obtained in the CUET-PG-2026 OR Composite score comprising of JUET-2026 + Academic Merit OR Academic Merit of the qualifying examination as per Order of preference already notified.
- The applicants are advised to bring original and copy of online application along-with one set of photocopies of all the academic qualification/category and other relevant certificate/s for depositing in the Department.
- The PROVISIONAL ADMISSION will be "COMPLETED" only after the successful payment of the Admission Fee.
- The LAST DATE for Admissions shall be 10-09-2026 and thereafter NO ADMISSION SHALL BE MADE FOR THE ACADEMIC SESSION 2026-27.
