

PG ADMISSION NOTIFICATION - 16 Filing of APPEAL(s) for Admission to the PG Programmes (Academic Session 2024-25)

This is for the information of all concerned that in case a candidate, who has filled his/her online Admission form in time, paid the requisite fee and participated in the admission process has any grievance and feels that the Statutes/ Guidelines governing PG Admissions have not been adhered to in his/her case, he/she may make an appeal on the Appeal Form prescribed for the purpose w.e.f. 28-07-2025 to 30-07-2025 and remit the requisite fee of Rs.530/-(Rupees five hundred thirty only) in form of DD favouring Registrar, University of Jammu, Jammu, payable at Jammu.

The decision of the Appellate Committee shall be final and binding.

The Appeal Form can be downloaded from the PG Admission Portal https://jammuuniversity.ac.in/PG/2025-26 All the requisite details are to be filled in by the applicant in his/her own handwriting. The applicant who desires to prefer an appeal will have to submit the Appeal Form/(s) to the concerned Head of the Teaching / Nodal Department along with all the supporting documents and requisite fee receipt.

- 1. Only genuine grievance where Statutes/Guidelines governing admissions have not been adhered to will be accepted. Incomplete and spurious appeals will not be considered.
- 2. Separate Appeal Form has to be filled in for each Programme.

The decision of the Appellate Committee w.r.t. the Appeal/s of the Candidate shall be final and binding upon the Applicant.**
