**\*Where there is a tie in GAT – B Score the merit of the candidate will be determined based on the last qualifying examination as per Jammu University Statutes.**

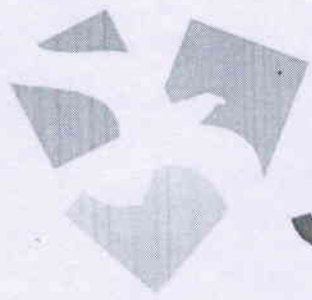
