(MID ENTRY ADMISSION & 3rd ROUND OF SEATS ALLOCATION)

It is for the information of all concerned that after completion of two rounds of allocation of seats the University announces MID ENTRY ADMISSION for the Candidates who appeared in CUET-PG-2024 but failed to apply for PG Admission CSAS-PG-2024 (Common Seat Allocation System-PG-2024), within the stipulated time, and are desirous of participating in admission process, for the vacant seats only can participate through the MID-ENTRY WINDOW, by paying a Non-Refundable MID-ENTRY FEE of Rs. 700/- (Rupees Seven Hundred Only), as per schedule given below:

Following GUIDELINES will be applicable for the ALLOCATION of Vacant Seats under Mid

- a. The candidates who have already admitted in any of the programmes in any of the previous rounds of allocation shall not be eligible for the Mid-Entre Admission.
- b. All the candidates who have already registered for PG admission form and not admitted in any of the previous allocated lists are also eligible for Mid-entry and need not to apply again. However, these applicants have to opt/fill FRESH PREFERENCES for the vacant seats. Preferences given in the earlier admission form shall become NULL & VOID.
- c. A candidate who applies in mid-entry will not hold any right to claim the seats allocated to candidates who had applied to CSAS-PG-2024 during the initial Application Phase. Allocation of seats to such candidates may be considered for subsequent rounds (if any), subject to fulfillment of eligibility criteria, availability of seats, and other CSAS-PG-2024 rules.
- d. Once the seat has been allocated to the candidate, it will be mandatory for him/her to take admission on the allocated seat. Failure to accept (FREEZE) the allocated seat will forfeit the candidate's right to seek admission to the course. The seat allocated in mid entry allocation round will be final and will not be upgraded in any subsequent allocation round.

- e. Mid-Entry will only be considered after successful remittance of the Mid-Entry fee. Merely applying through Mid-Entry does not guarantee a seat.
- f) In the Mid Entry, the allocation will be done on the basis of following Criteria.
 - i) Availability of Seats in a particular Programme/ Campus
 - ii) Program Specific Merit
 - iii) Order of Preference of Deptts/ Campus/ College
- iv) Category.
- Any other allocation rules, policies or criteria mentioned in the notified guidelines on the admission website.
- g) Once the candidates are provisionally admitted in the Final Allocation, the admitted candidates will be required to Visit the Allocated Department/ Nodal Department for physical verification of documents at the department along with their original documents.
- h) The candidates will be considered admitted only after successful remittance of the requisite admission /Self Finance fees.
