W.r.t. the item No. 34, it was noticed that only five departments have sent their progress reports about the MOUs signed by the University and the Vice-Chancellor impressed upon all the Heads of the Departments to furnish the progress report of the MOUs with respect to their Departments on urgent basis as the same has to be reviewed annually as per the University Council Resolution in the matter.

For Ph.D<sup>\*</sup> thesis evaluation, panel of examiners must have eight examiners, half of them preferably from prestigious Universities located in distant parts of the Country. Further no examiner be repeated in a particular calendar year, unless it is absolutely unavoidable.




