2. <u>INTRODUCTORY REMARKS</u>:

At the outset, the Dean Academic Affairs welcomed all the members and the Vice-Chancellor to the meeting of the Academic Council. The Vice-Chancellor in his maiden Academic Council meeting exhorted upon the University fraternity to use all modes of technology, which enables the University to fasten its admission/registration/examination and result declaration in time. He impressed upon the Director, Centre for IT enabled Services and Management to extend all kinds of help to various wings/departments of the University so that University could come up to the expectations of its students.

The Vice-Chancellor also exhorted that the Academic Council holds an imminent position, being the highest academic body of the University and the University is known for its academics, research and other extracurricular activities.
