At the outset, Prof. Umesh Rai, Vice-Chancellor, University of Jammu welcomed all the members present in the meeting and thanked them for sparing their valuable time to attend the meeting. During the meeting the members of University Syndicate highly appreciated the Innovative Knowledge Initiative taken up by the University of Jammu, support of the Finance Department J&K Government, Higher Education Department J&K Government, guidance and support of the Hon'ble Vice-Chairman, J&K Higher Education Council and most importantly the vision, unconditional support and patronage of Shri Manoj Sinha, Hon'ble Lt. Governor, U.T. of J&K (Chancellor University of Jammu) for organization of 14-days educational tour "College on Wheels- Gyanodaya Express" for the female students of J&K.

Thereafter, the agenda of the meeting was presented by the Registrar and decisions recorded are hereunder:

ITEM No.: 121.32

Considered the request of Sh. Amrit Paul Singh, Storekeeper working in the Department of Physics for up-gradation of Pay Scale from 4000-6000 to 5000-8000 (pre-revised) on the analogy of Computer Assistants & others.

Considered the payment of salary to the University employees out of its own Corpus fund in case the salary is not credited by the J&K UT Government by the last date of any month to be later recouped as and when the salary grant is received from the J&K UT Government proposed to be credited in the official account of the Registrar under these circumstances instead of Individual account of the University employees.

The matter was discussed threadbare and the worthy Syndicate members were apprised by the Advisor to the Finance Department, J&K Govt. that the proposal has already been sent to the Principal Secretary, Higher Education for his considered opinion. In response, the Principal Secretary, Higher Education Department informed that the Higher Education Department does not have any objection to the proposal subject to the condition that there is no infringement of the prescribed rules.

It was resolved that the Finance Department may consider proposal for the payment of salary to the University employees out of its own Corpus fund, in case the salary is not credited by the J&K UT Government by the last date of any month. Under these circumstances, the salary shall be credited in the Official account of the Registrar, University of Jammu instead of Individual accounts of the University employees, so that the same be credited back to the


